Mike V suggested that we bring in two or three high profile figures and have them work with us on a video on voting? Greg D suggested that we use retired officials, your voice is your vote and both matter.



Carla suggested creating a "did you know?" article/column in the press or to be shared on social media to educate voters on the roles of different election officials.

Sharon asked Mike V to create an outline proposal for the committee to consider so we can review and discuss at our next meeting.
